Areas In Which Research Is Done:

Drawings and paintings utilize a personal expressionistic/abstract style of painting. The painter's studio is the subject, more specifically the wall of the studio and the canvases which are overlapped on it, or against it. These Paintings are photographed and become the source for the next painting. Probing deeper and deeper generations of paintings uncover inner feelings, and have become progressively larger. Specific imagery related to Vietnam landscape, aerial flight, moonlight/sunlight, day/night/ masking tape/linen/strip frames/studio, is discernable, in a space that is meandering into vast landscape expanses and room-like interior.

"Calculations" are developed from Polaroid/Camcorder photos of previously completed and framed works against the studio wall-- side by side/ overlapped, or still tacked to the wall in order to create possibilities that interest Olsen's notion that 'this could be Painting'. A format 'window' for the black and white or color photo is cut out on graph paper. The graph paper provides a grid to plot the next painting for its size, shape, direction, scale. Color and state changes are intuitive.

The Myth of Sisyphus is like painting...the act of struggle pushing the Monolithic Stone up the hill in a place where there is no light, no day, only the endless struggle. During this moment, purpose...the act itself, memory, ancestry surface.
